# Fairventures is looking for a **Short-Term Researcher**

#### **About Fairventures Worldwide (FVW)**

Fairventures Worldwide FVW is a Germany-based non-profit development organization that drives forest landscape restoration. We partner with communities to develop site-specific solutions, ranging from reforestation with fast-growing tree species to non-timber forest products and agroforestry. We aim to restore ecosystems and create livelihood opportunities for local communities on the ground, while contributing to the mitigation of climate change and creating added value along the entire value chain.

FVW is currently active in Indonesia and Uganda. We are looking to expand in the future, and have identified three countries for potential expansion: **Tanzania, Malawi and Vietnam**. We are launching the Desk Research stage of our assessment now and are looking for short-term researchers to focus on each of the countries. FVW is looking to hire 3 separate consultants. Each consultant should have orientation to one of the 3 countries mentioned above.

### **Researcher Requirements**

- Orientation to reforestation and development projects in Tanzania, Malawi or Vietnam
- Organized and detailed self-starter who can work unsupervised
- Immediate availability
- Ability to complete the research project in 22 days. The assignment is large and must be completed in 1 working-month
- Familiarity with the leading research bodies related to development (see Matrix)
- Professionally Outgoing: Able to organize meetings with senior staff, lead discussions and interviews and present the results
- Professional English-Writing Skills: Ability to summarize and analyze dense English Language texts
- Fluent English: Written, spoken, reading and comprehension
- Fluent Sawhili if applying for the position in Tanzania
- Fluet Vietnamese if applying for the position in Vietnam
- Proficiency in Cloud-based platforms and ability to work exclusively with the cloud, specifically Google Workspace. Instructions and access will be provided
